Privacy Policy

Introduction

BrandGen.io. ("BrandGen.io," "we," "us," or "our") loves data. We also respect your privacy and the rights that you have. Therefore, we are committed to protecting the information we gather through our site, and we will remain compliant with this Privacy Policy ("Policy"). This Policy contains the types of information we may collect from you or that you may provide when you visit the website www.brandgen.io ("Website") or any affiliated sites and our practices for the use of that information.

This Policy applies to any information that we collect on the Website, including any information in posts, emails, texts and other electronic messages between you and the Website and any information about you transferred to the Website from other websites. This Policy does not apply to information that we collect by any other means.

We invite you to read this Policy so that you will understand our policies and practices regarding your information and how we may use it. By visiting or using our Website and agreeing to our cookie policy, you agree to the terms of this Policy. This Policy may be updated from time to time. Your continued use of the Website after we make changes is deemed to be acceptance of those changes, so you're welcome to check this Policy periodically for updates.

Section 1: Information We Collect and How We Collect It

We use authentication and encryption tools such as SSL when appropriate to protect the security of your Personal Information. We strive to protect the information that you share with us; however, no data transmission over the Internet has a guarantee of total security, so you must share information at your own risk.

We may collect information from and about users of our Website that is personally identifiable ("Personal Information") such as your name, address, phone number, or email address. We obtain this information when you register, submit a form, subscribe, enter a promotional offer, or chat with a bot. We observe an opt-in policy, so we will not store or use your Personal Information for marketing purposes without your consent. We also store correspondence that you share with us. As you navigate through the Website, we may automatically track traffic data and usage information so that we can manage content and enhance or personalize your use of the Website. We also automatically collect non-personal information, such as your IP address, browser type, operating system, and usage information to evaluate and improve the performance of our services. This data collection may include cookies that are stored on your computer, small embedded web beacons, or other types of embedded code on the Website to obtain statistics and verify system and server integrity.

Section 2: How We Use or Share Your Information

We use information that we collect to provide you with inspiration, information, services, and to fulfill any purpose for which you provide your information.

Our purposes may include:

- Gathering analytics of website visitors and their actions on the Website
- Providing helpful information that meets your needs

Marketing and promotional purposes

We may combine information of users into aggregated data that does not disclose any Personal Information of the individual user. We may also disclose information to comply with any law, legal process, or court order requirements and to respond to any government or regulatory request of audit, or if we believe disclosure is necessary or appropriate to protect the rights, safety, or property of ourselves, our customers, or others.

Section 3: Third-Party Integrations

Section 4: Accessing and Updating Your Information

We evaluate requests per case as they are received and may not accommodate a request to change information if we believe the change would violate any legal requirement or law, or cause information to become incorrect.

If you are under the age of 13, you should not provide any Personal Information, use interactive features, or make comments on our Website. If you are a resident of California or outside of the United States, we abide by standards of CalOPPA and GDPR. Please note that our website is hosted within the US, and it is possible that certain information will be stored on servers in other countries or in a cloud-based service or other similar hosting platforms. we do not disclose your Personal Information to third parties for their direct marketing purposes.
